Seminars: Nov 3rd - 2006 IBC/IFC Solving Means of Egress in Commercial Buildings Instructor: Terrell Stripling, ICC. *Provides knowledge of fundamental requirements for means of egress including practice problems related to each egress issue from a set of plans for a 4-story commercial building.*
Nov 4th - 2006 IBC/IFC Fire Protection Systems Instructor: Terrell Stripling, ICC. *Describes fire protection systems code requirements as contained in the 2006 IBC and IFC. Addresses the 2006 IFC requirements relating to fire protection systems, including the most common types of automatic sprinkler systems, alternative automatic extinguishing systems and standpipe systems.
